

## **Soldo Fuel Cards Campaign 2024 T&Cs**

Terms and Conditions for the Soldo Fuel Cards Campaign 2024.

### **Promoter:**

Soldo Software Ltd, (company No. 09233754), registered address 119 Marylebone Road, C/O WeWork, London NW1 5PU, England (“**Soldo**” or “**Promoter**”).

What is meant by “**Participant**” or “**You**”: Participant is

- i) someone who has never had a Soldo account,
- ii) has landed on any Fuel Card Campaign landing page on the Soldo website (<https://www.soldo.com/en-gb/fuel-cards/> et al) via a relevant search keyword;
- iii) and has decided to register with Soldo and subscribe to the Soldo Plus or Standard Plans.

### **Eligibility:**

This invitation is valid only to legal residents of Italy, United Kingdom, and other EEA countries covered by Soldo’s services who are eighteen (18) or older at the time of Entry. Participation constitutes the Participant’s full and unconditional agreement to these T&Cs and the Promoter’s decisions, which are final and binding in all matters related to the Soldo Fuel Cards Campaign 2024.
